Section 4. First-aid measures

Description of necessary first aid measures

Eye contact

Skin contact

Ingestion

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Do not breathe vapor or mist. Provide adequate ventilation. Environmental precautions

Methods and materials for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures
