Description of necessary first aid measures

Eye contact

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Ingestion

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Methods and materials for containment and cleaning up

Small spill
