## Section 4. First aid measures

### Description of necessary first aid measures

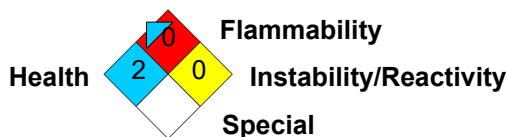
