### Section 4. First-aid measures

#### **Description of necessary first aid measures**

**Eve contact**: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

#### Methods and materials for containment and cleaning up

Small spill

Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). #### Precautions for safe handling

**Protective measures**

# Appropriate engineering controls
