#### DESCRIPTION

Based on a special acid chemistry, Metal Pretreatment Wipes 495 from Axalta is ready-touse and will make the metal pretreatment process very fast and easy. The wipes provide both adhesion and corrosion protection for the subsequent paint process.

# APPLICATION

SUBSTRATES Bare steel sanded and cleaned Galvanized steel or soft aluminum sanded and cleaned

#### SURFACE PREPARATION

Substrates must be dry and free from grease, oil and other foreign matter before pretreatment of Axalta Metal Pretreatment Wipes 495 application. 495 is not a cleaning wipe.

#### **APPLICATION**

Apply even and thoroughly in a cross-wipe application method. Ensure the surface remains wet for at least 1 minute. This is necessary for an effective metal passivation.

Only apply on bare metal areas. The same wipe should not be used for different types of metal surfaces.



# DRY TIMES

Ensure the surface remains wet for at least 1 minute. Allow the wetted surface to dry at ambient temperature. Surface needs to be dry, apply undercoat within 15 minutes.



## TIPS FOR SUCCESS

- Not recommended for use under 1K primer, Wash Primer, polyester products and UVcured products.
- Axalta Metal Pretreatment Wipes 495 should be protected from freezing. If the wipes are frozen, they are irreversibly damaged and cannot be used again.
- Suitable personal protection equipment is recommended during application: rubber gloves are of particular importance in addition to protective work clothing and safety goggles.
- Always reseal the wipe package immediately after removing saturated wipes.
- For multiple use, wipes can be stored in a closed plastic-bag or container for maximum one working day. Used wipes should not be returned to the original container.
- If free fluid accumulates in the bottom of the wipe package roll the package horizontally to reabsorb the fluid.
- Dried out wipes must be discarded as they cannot be used or moistened again.
- The waterborne Axalta Metal Pretreatment Wipes 495 are chrome free.
- Coverage: 1 wipe/ 20 sq. ft.
