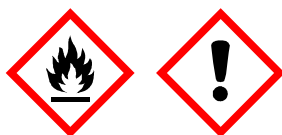

Section 4. First aid measures

Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

Methods and materials for containment and cleaning up

Appropriate engineering controls

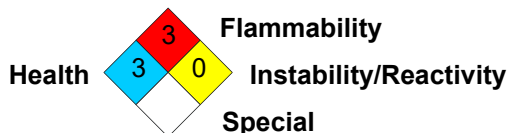
