Section 4. First aid measures

Description of necessary first aid measures

Precautions for safe handling

- Appropriate engineering controls** : Use only with adequate ventilation. 

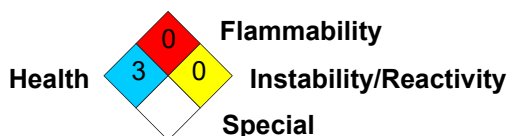
