#### **Description of necessary first aid measures**

Eve contact : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

#### Methods and materials for containment and cleaning up

Small spill

## Precautions for safe handling
