### **Description of necessary first aid measures**

**Eye contact**: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

minutes. Get medical attention. If necessary, call a poison center or physician.

**Inhalation**: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it

### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

### Methods and materials for containment and cleaning up

Small spill

## Precautions for safe handling
