Description of necessary first aid measures

Eye contact

Inhalation

If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. Methods and materials for containment and cleaning up

Small spill

Section 7. Handling and storage

Protective measures


